### **ABOUT THE PROGRAM**

The University of South Alabama Center for Disaster Healthcare Preparedness (CDHP) is pleased to announce the 2018–2019 CDHP Training Programs (CDHP 2019). CDHP is funded by the Alabama Department of Public Health (ADPH) Center for Emergency Preparedness (CEP) through a cooperative agreement with the U.S. Department of Health and Human Services, Office of the Assistant Secretary for Preparedness and Response (ASPR).

CDHP Road Show is designed to bring healthcare coalition preparedness and response activities on site to coalitions and healthcare facilities across the State. The primary goal of the program is to allow participation by more regional staff in their own facilities, invite district neighbors/response partners, and enhance collaboration in the healthcare coalitions by providing an understanding of disaster healthcare preparedness. CDHP Road Show, in the form of training sessions or workshops, will be designed through input from Healthcare Coalitions, healthcare association and healthcare facilities needing to meet identified gaps. CDHP Road Show key topics are timely, updated and consistent with both existing and developing threats faced by the healthcare, public health, disaster response communities, as well as those required by 2019 HPP and overlapping PHEP programs.

USA CDHP plans to provide up to thirty-six (36) CDHP Road Shows to Healthcare Coalition member agencies, healthcare associations and healthcare facilities.

**COSTS:** There is NO registration cost associated with this program. USA/CDHP does not provide reimbursement for any related travel costs (such as local mileage, lodging, or food costs) for CDHP Road Show. Any costs incurred by the attendee are the responsibility of the attendee.
